## Risk Rating

15-25	HIGH	A HIGH risk requires immediate action to control the hazard. Actions taken must be detailed within the risk assessment.

## HAZARDS ASSOCIATED WITH ACU PERMITTED EVENTS TAKING PLACE DURING THE COVID-19 CRISIS

### SAFETY ASSESSMENT STATEMENT

1. This Risk Assessment has been produced which outlines hazards associated with motorcycle sport events taking place in a Covid-19 environment.
2. The Risk Assessment takes into consideration hazards to participants/Coaches/families during a period once UK Government advice/guidance allows for Lockdown restrictions to be lifted. It should be noted that following the latest UK Government advice, this Risk Assessment comes into effect as at 4<sup>th</sup> July and adheres to the lifting of restrictions outlined by the government. However, it should also be noted that in the event of a second peak of Coronavirus and in accordance with any future UK Government Advice /Guidance, this Risk Assessment may be replaced for more stricter measures or events shut down in their entirety
3. The Risk Assessment allows for motorcycle sport events to take place in a responsible, controlled, and safe manner, but always taking into consideration government advice/guidance published or issued at any time.
4. Government Advice / guidance will take precedent and will always be followed by ACU Ltd and the ActivityOrganiser adopting this Risk Assessment.
5. Organisers may wish to adopt this risk assessment as their own and in doing so may add additional measures to suit local needs. If using this risk assessment, an Organiser accepts responsibility for its content and accepts the control measures that have been identified.
6. Organisers must consider that if they do not adhere to national Government Guidance / Advice or indeed the advice issued by ACU Head Office, they risk the event insurance being invalidated.
7. Organisers in Scotland, Wales and the Isle of Man, whilst following the guidance contained in this Risk Assessment need to also follow the specific advice/guidance issued by respective national Governments.

As the initial assessed level of risk has reduced, so the residual level of risk has been re-assessed as a result of recommended control measures to be put in place considered to be suitable and sufficient and to adopt a position of as low as is reasonably practicable in terms of the control measures put in place to mitigate the risk.

### RISK ASSESSMENT

Given the global spread of Coronavirus, consideration has to be given to what will be the 'new normal'. The way in which Training activity were conducted prior to Covid-19 will not be possible for some time to come, if ever. The following should be considered as guidance for Coaches who should consider producing their own Risk Assessment / Methodology Statement or enhancing on what is given below dependent on local circumstances. Consideration has therefore been given to the following (but is not limited to):

**Travel to/from the Venue.** Travel to and from the circuit/venue would be dependent on current UK Government advice / guidance in place at the time, in terms of the number of persons in a vehicle and those persons being from the household / support bubble etc. If participants or someone in their household or support bubble are showing coronavirus symptoms, everyone in that household / support bubble should stay at home. If a participant or a member of the household or support bubble are contacted as part of the test and trace programme, the individual contacted should stay at home. If that individual becomes symptomatic, everyone in the support bubble must self-isolate and stay at home.

**Event Duration.** Overnight stays at a venue / camping and/or overnight stays at local Hotels / B&Bs / other accommodation should follow guidance / advice issued by the UK Government. Officials / competitors camping overnight at a venue must follow the instructions issued by the Organiser which are put in place for the safety of everyone and Camper vans / tents etc should be spaced accordingly in accordance with any UK Government guidance / advice issued in respect of social distancing measures.

**Social Distancing.** Training activity can be conducted on the basis that a Group does not exceed six people and that within that Group, Social Distancing Measures have to be adhered to in accordance with UK Government Advice / Guidelines. That is to say that social distancing should be adhered to between the Coach and the Riders and in between each rider. Training activities should take place outside, only where outside facilities are not possible should training indoors be considered. Vehicles should be parked at an appropriate distance to respect social distancing measures. The form of Training to be given can be either on-bike or off-bike training. Therefore, either forms of training cannot be seen as being peripheral and, in many respects, complement each other.

**No Spectators.** Except for close family members (parent / legal guardian), no additional personnel should be included / spectating whilst the training activity is being conducted.

**Restriction on the number of Participants.** As above, a Training should be held in Groups of six including the Coach or Coaches. It should be noted this does not include beginners. Riders need to be more experienced than a novice/complete beginner. The rider needs to have a basic understanding of the controls of the machine to negate a Coach having to physically touch the machine to demonstrate how the machine operates. In accordance with up to date UK Government Guidance / Advice, Training Groups should not exceed six people. There is no defined make up of a Group, so this could be One Coach to five riders or Two Coaches to three riders each or other variances as long as a Group does not exceed six people. For clarity and for the purposes of this ACU Training Risk Assessment in light of Covid-19, a youth is designated as being a minor under the age of 17 years. It is appreciated that a member of the family will need to be present, but if this is the case, those family members should be restricted to a minimum and those individuals need to socially distance themselves from others in accordance with existing UK Government Guidance / Advice. Engine capacities relevant to age still applies.

**Signing On.** Signing on should take place with current social distance measures in mind (social distancing measures issued by the UK Government currently stipulate a two-metre distance between each person). A wet signature is still required at Signing On. Trainers should make provision to obtain disposable pens for participants to sign on and then wrap up in tissue/paper towel and dispose of in a bin/ receptacle or ensure the participant is aware they are required to bring a pen with them to sign on. Individual slips of paper (complimentary slip size) will be required to be signed by each individual to state the participant agrees with the requisite declarations as defined on the Entry Form for the event. The slips of paper should then be placed in an envelope and sealed.

The envelope is to remain sealed for a period of four days which will be enough time for any traces of Coronavirus to be eradicated. The Trainer should be the only person to handle the envelope once the requisite signing on process has been completed.

**Litter and Waste.** It is the responsibility of each Trainer/participant to take their own litter / waste away with them. This should happen as a matter of course, but given the circumstances surrounding Covid-19 this is now much more prevalent.
