## HAZARDS ASSOCIATED WITH ACU PERMITTED EVENTS TAKING PLACE DURING THE COVID-19 CRISIS

### SAFETY ASSESSMENT STATEMENT

1. This Risk Assessment has been produced which outlines hazards associated with motorcycle sport events taking place in a Covid-19 environment.
2. The Risk Assessment takes into consideration hazards to competitors/officials/marshals/teams/mechanics/families/spectators during a period once UK Government advice/guidance allows for Lockdown restrictions to be lifted. It should be noted that following the latest UK Government advice, this Risk Assessment comes into effect as at 4<sup>th</sup> July and adheres to the lifting of restrictions outlined by the government. However, it should also be noted that in the event of a second peak of Coronavirus and in accordance with any future UK Government Advice /Guidance, this Risk Assessment may be replaced for more stricter measures or events shut down in their entirety
3. The Risk Assessment allows for motorcycle sport events to take place in a responsible, controlled, and safe manner, but always taking into consideration government advice/guidance published or issued at any time.
4. Government Advice / guidance will take precedent and will always be followed by ACU Ltd and the Event Organiser adopting this Risk Assessment.
5. Organising Clubs may wish to adopt this risk assessment as their own and in doing so may add additional measures to suit local needs. If using this risk assessment, an Organising Club accepts responsibility for its content and accepts the control measures that have been identified.
6. Organising Clubs must consider that if they do not adhere to national Government Guidance / Advice or indeed the advice issued by ACU Head Office, they risk the event insurance being invalidated.
7. Event Organisers in Scotland, Wales and the Isle of Man, whilst following the guidance contained in this Risk Assessment need to also follow the specific advice/guidance issued by respective national Governments.
8. As the initial assessed level of risk has reduced, so the residual level of risk has been re-assessed as a result of recommended control measures to be put in place considered to be suitable and sufficient and to adopt a position of as low as is reasonably practicable in terms of the control measures put in place to mitigate the risk.

### RISK ASSESSMENT

Given the global spread of Coronavirus, consideration has to be given to what will be the 'new normal'. The way in which motorcycle sport events were conducted prior to Covid-19 will not be possible for some time. The following should be considered as guidance for Organising Clubs as availability of land, size of Club, level of meeting may be different in each situation. Therefore, Clubs may also wish to consider drafting their own Risk Assessments /Methodology Statements or enhancing on what is given below dependent on local circumstances. Consideration has therefore been given to the following (but is not limited to):

**Travel to/from the Circuit/Venue.** Travel to and from the circuit/venue would be dependent on current UK Government advice / guidance in place at the time, in terms of the number of persons in a vehicle and those persons being from the household / support bubble etc. If competitors / officials or someone in their household or support bubble are showing coronavirus symptoms, everyone in that household / support bubble should stay at home. If a competitor / official or a member of the household or support bubble are contacted as part of the test and trace programme, the individual contacted should stay at home. If that individual becomes symptomatic, everyone in the support bubble must self-isolate and stay at home.

**Signage.** Signage needs to be prominent at the entrance to the venue and in locations where persons are likely to congregate to emphasise any social distancing measures that may be in place in accordance with UK Government advice/guidance issued.

**Paddock space/competitors/Officials parking.** Organisers must make provision and restrict the entry as appropriate to allow for the parking of vehicles to adhere to existing UK Government guidelines regarding social distancing. It is recommended that a vehicles width should be left between parked vehicles. Competitors awnings / service areas (tents / gazebos must be established with existing social distancing measures being adhered to.

**Entry to the Event.** Entry fees to be paid online prior to the event. No cash should be taken/accepted on the day of the event. Payment to be made via the ACU On-Line system or a system already set up and in place by the Organising Club.

**Rule of Six.** To try and combat the recent spike in Covid-19 infections, the Rule of Six has been enforced by the UK Government for England which became effective as at 14<sup>th</sup> September. NB. This applies to England only, Organisers in Wales, Scotland and Crown Dependencies should follow guidance/advice/rulings from their own Government/Administrations. For England, the Rule of Six means:

- Competitors / Teams to have 'groups' of no more than six in their awnings.
- Wear face masks when moving outside of their awning.
- When queuing for food/beverages at food outlets to wear face masks.
- Maintain social distancing as per current UK guidance/advice

**Event Duration.** Overnight stays at a venue / camping and/or overnight stays at local Hotels / B&Bs / other accommodation should follow guidance / advice issued by the UK Government. Officials / competitors camping overnight at a venue must follow the instructions issued by the Organiser which are put in place for the safety of everyone and Camper vans / tents etc should be spaced accordingly in accordance with any UK Government guidance / advice issued in respect of social distancing measures.

**Spectators at ACU Permitted Events.** Spectators can be admitted to ACU Permitted events if individual Organisers feel confident within themselves that they are content to allow spectators into their event and that they have the capability / space at the venue which allows Social Distancing Measures to safely take place. Organisers must ensure the following:

- A Risk Assessment has been put in place to ensure control measures have been considered to mitigate the risk of infection (as outlined in the Safety Assessment Statement above, this risk assessment may be used provided the Organiser accepts responsibility and puts in place the control measures outlined in this document.
- The Local Authority is contacted to inform them of the intent to hold an ACU permitted event and that it is intended to allow spectators into the venue and to confirm that suitable control measures have been put in place to ensure the venue is Covid-19 Secure as per the guidance / advice issued by the UK Government and the Auto-Cycle Union.
- The Landowner is content for the event to take place and the landowner is content that spectators will be admitted to the event.
- A Track and Trace method is put in place to record details of spectators being admitted to the event.
  - There is not a requirement to take details of every individual, based on the fact that any other persons in the vehicle / pillion passenger are from the same household / support bubble, but details of the driver of the vehicle or rider of the motorcycle should be recorded.
  - The details required are: Name, postcode / house number. Mobile number and/or email address.
- The Paddock should be segregated, and no access allowed to Spectators.
- Spectator groups to be no larger than six in a group. Face coverings to be worn as appropriate, particularly when queuing to use the toilet facilities or food/beverage outlets.

**Restriction on the number of Competitors.** Social distancing and keeping everyone safe is of paramount importance now the UK Government have lifted some of the restrictions on lockdown. As such, it may be necessary to limit the number of competitors at each event in order to maintain social distancing measures. The number of competitors per event is dependent on the venue and the provision of space suitable enough to park vehicles in a manner which adheres to social distancing measures.

Therefore, the number of competitors per event is at the behest of the Organiser. It is important though, that social distancing measures and as such the parking of vehicles is carried out in a sensible manner not to contravene current UK Government Advice / Guidance.

**Extreme Enduro Events.** Because of the nature of Extreme Enduro events, some specific considerations need to be taken into account;

- Where there is a particularly difficult hazard that would normally tend to attract spectators and team personnel, clear signage should be displayed to emphasise the requirement for Social Distancing. Additionally, should an Organiser consider it necessary, taped areas to separate / segregate any public may need to be established.
- The whole event should be regarded as a 'No Help Zone' and no person other than the Rider should be in contact with a machine.
- Sufficient Marshals should be appointed to ensure the above and they should be provided with appropriate PPE (face coverings / gloves).
- When a machine / rider has fallen or failed to negotiate a hazard, only the rider can re-attempt that hazard. Marshals should only get involved for safety reasons or if machines are in danger of causing harm to the rider or others. If Marshals are required to get involved, they should wear face coverings and gloves.
- Pit / Service areas must only be manned with the minimum of mechanics/crew who must also wear suitable PPE and observe social distancing protocols.
- Riders returning to pit/service area at any time must observe social distancing measures between other riders, public and pit/service crews.

**Travelling Marshals.** Dependent on the length of the Course, Travelling Marshals should be utilised to maintain safety and respond to incidents as required. Travelling Marshals must be briefed particularly regarding the requirement for them to contact Event Control via radio / mobile phone to request medical assistance where appropriate. The Course should be divided into Sectors and Travelling Marshals deployed to pre-designated positions. The identification of Sectors is important so that Travelling Marshals can relay the correct information back to Event Control.

**Signing On.** The competitor should enter the event via the ACU On-Line System. The competitor enters the event via the ACU On-Line System or an On-Line System operated by the Organising Club and in doing so receives a riding number for the event. The competitor then prepares his own card/number plate with his riding number displayed on it. At signing on, the card is held up to the Secretary at a safe distance to the Secretary who is socially distanced with appropriate PPE or behind a plastic transparent screen who will tick the riders name off the Start List to confirm his attendance. Until notified otherwise, One Event Licences are not permitted at ACU permitted events. Please note; It is incumbent on the Rider to ensure he attaches his own riding number to his machine.

**Signing On for Officials/Marshals.** Where possible prior to the event, Officials / Marshals should be listed on the Officials Signing On form. When they come to 'sign on', they are read the declaration and then their name ticked off on the Signing On sheet. For the Officials/Marshals, whose names doesn't already appear on the Signing On form, those individuals sign on as normal and following the use of a pen, the pen is quickly sprayed/wiped with a sanitizer/wipe before it is used again. This will prevent cross-contamination. Equally, individuals should be encouraged to use their own pen to sign on with. Face coverings should be worn during the signing on process if local conditions deem it necessary to do so. Following the signing on process, all paperwork should be secured in a box/container for a period of 72 hours to allow any traces of the coronavirus to die off.

**Technical Inspection.** Technical Inspection should be carried out in a spacious, non-enclosed environment. Machines/helmets/body armour etc. will be inspected visually by the Technical Official. Under the supervision of the Technical Official the competitor will be instructed to demonstrate the working condition of brakes, throttle and footrests etc. A visual inspection of the helmet for signs of damage and the presence of a gold stamp will be carried out without handling the item. Technical Officials will be provided with appropriate PPE. Hand sanitiser will be provided for Technical Officials use. Completion of any necessary declarations will be as per the measures outlined for the Signing On process. Noise Testing to be completed as per existing ACU regulations with Social Distancing measures being adhered to.

**Mechanics.** Competitors to be restricted to one mechanic per rider. The mechanic to use his own tools only. Tools should not be shared. Mechanics are to observe social distancing measures whilst at the event and should travel to/from the event in a separate vehicle unless the mechanic is from the same household as the competitor.

**Course Equipment.** Course Equipment should be sanitised prior to use and individuals handling Course Equipment should wear appropriate PPE. Where possible and where appropriate, the same person should be handling the same piece of equipment. Once the event is finished, equipment should be sanitised and stored in a central location.

**Podium Celebrations.** No podium celebrations to take place. Any awards given, to be handed out by the Event Administration at the end of the event observing Social distancing measures.

**Protests / Disputes.** Any protest or dispute is to be dealt with by email / electronic means after the event.

**Food Outlets.** In accordance with UK Government Advice/Guidance, Event Organisers may wish to make the necessary arrangements to safely operate on-site catering facilities / external food outlets (burger vans etc). Government advice should be adhered to and it is also recommended that an external Vendor provides a risk assessment to demonstrate he is operating safely and in accordance with up to date government regulations.

**Trade Stands.** Event Organisers may allow Trade Stands into the venue. Trade Stand Operators should provide a risk assessment to demonstrate they are operating safely and in accordance with up to date government regulations.

**Communication.** At Cross Country / Hare & Hounds events, a loudspeaker communication system must be established for all communications. Classes / Riding order must be called via the loudspeaker system and then the competitors to proceed from the Paddock area to the Start/Waiting area. Only those Classes called are to proceed to the Start / Waiting area. No other machines are to be outside Paddock / Pit / Service Area.

**Start of Competition.** When instructed to do so, riders must travel directly from the Paddock or Parc Ferme to the Start Area. The method of starting will be indicated in the event Supplementary Regulations which will take into consideration social distancing measures in place as per UK Government / devolved government / local government advice. In particular, the distance between riders machines each side and to any machines front and behind must observe social distancing measures currently in place at the time of the event. Any Start Officials must be situated at an appropriate distance from the Start Line and PPE (face coverings) must be worn. When riders start in Groups or 'waves' the minimum social distancing measures must also be observed between Groups.

**Service during the Event.** If a rider leaves the marked Course for service during the event, they must follow the directions given at the Briefing and main Social Distancing measures at all times as well as following appropriate signage to Paddock / Service Areas.

**Finish.** At the finish of any heat or at the end of their event, after passing the finish line, riders must immediately return to the Paddock. Parc Ferme or Service area as directed and not stop at the finish to converse with crew members or review times/positions etc. The Clerk of the Course will give direction on this at the pre-event briefing.

**Results.** Results must be promulgated by the use of the loudspeaker system or sent by electronic means. To minimise mass gatherings, no paper or monitor results should be displayed.

**Toilet Facilities.** The use of toilet facilities may need to be monitored to observe social distancing measures. Event Organisers should provide hand sanitisation methods and Signage should be displayed to emphasise hand washing/sanitisation. Competitors / Officials are responsible for providing their own handwash facilities whilst in the Paddock area.

**Litter and Waste.** It is the responsibility of each rider / Official / member of the public to take their own litter / waste away with them. This should happen as a matter of course, but given the circumstances surrounding Covid-19 this is now much more prevalent.

**Additional Costs.** Organising Clubs should be aware of the additional costs involved in providing additional/enhanced cleaning of toilet facilities. Also, it should be borne in mind the requirement to provide manual monitoring of access to toilet areas. If no individual in the Club volunteers to take on this role, this role may have to be paid for.
