Entries: Having entered the event, if you become a non starter you must explain your absence to the promoting club. Entries must be made online or on the official entry form. All entrants must show their club membership card and licence when signing on at the event and state the number on the entry form. All riders must hold a valid ACU licence, day licences are available. The club reserves the right to refuse any entry without giving a reason.

Yellow Waved: Great Danger, prepare to stop, no overtaking. A significant reduction in speed must

be seen; therefore jumps should not be attempted.

Fuel: All fuel used during an event must comply with 2016 ACU Fuel Regulations

The riding in the paddock of any pit bikes or mini bikes is not allowed. Dogs must be kept on a leash at all times.
