Medical Repatriation Insurance for non-ACU/SACU Licence Holders

All riders who do not hold an ACU or SACU Licence must produce a start permission from their own federation in order to compete in the event. Under FIM Regulations, the start permission must also provide insurance cover for the following benefits:

In case of permanent disability	EUR 50,000
Death	EUR 25,000
Medical Treatment	EUR 10,000
Repatriation	EUR 4,000

In addition to the above, it is mandatory for all non ACU and SACU Licence holders to have a minimum sum insured for medical and repatriation insurance as follows for the 2014 MGP and Classic TT Races and official practice:

Medical Treatment/Repatriation	EUR 260,000

Participants should arrange this extra cover with their own Federation prior to attending the event. Alternatively, the ACU insurance brokers, Lockton Motorsport can provide this cover for the following premiums:

Road Traffic Act (RTA)

Lockton Motorsport, have a facility for RTA cover for competition bikes which are being ridden on the Public Highway.

The cost of cover is £30 per bike and insures the bike whilst being ridden on the Public Highway, to or from official practice or to and from competition.

The duration of cover is 3 (three) hours before the roads are closed and up to 2 (two) hours after the roads are re-opened.

The cover is not valid for testing on the Public Highway or for social riding.
