#### CLASSES

#### **COURSE**

The start is at Pateley Bridge Auction Market map ref 99/156 653. The route will be 1 lap approx 35 miles in length and will contain the Public Highway. There will be 28 to 35 sections contained with in the route.

A descriptive route card will be provided for each competitor. Route maps will be displayed at signing on and route markers will be placed on the course. It is the competitors responsibility to follow the correct route and visit all sections. The event will start at 10.00am
