Supplementary Regulations

Announcement – The Yeadon Guiseley & District Motor Club Ltd will organize a National trial held under the National Sporting Code, the Standing Trials Regulations of the ACU, the ACU S3 Parts National Trials Championship Regulations and any final instructions that may be issued.

Eligibility – As per ACU S3 Parts National Trials Championship. Riders must hold a current ACU Trials Registration card or SACU Licence. Other riders must produce a licence and Start Permission confirming Insurance from their FMN.

Venue - Dob Park, Otley, N Yorkshire LS21 2NA & Surrounding Area

Start Time - First rider 09:31AM the rest as per Championship Regulations. Riders on Non-Championship Route will start first.

Course - Will consist of 1 lap of 40 sections – **with approx 35 miles of road work*** **Time Limit** - 6 HOURS tbc

***It is the responsibility of the rider to ensure that both his/her machine and him/herself are fully legal for the purpose.**

Method of Marking – The Championship will be held under **TSR22B NON STOP**

Entries – Riding Numbers/ Start Times will be allocated in reverse – early entry = late start on each of respective Routes ie. Championship or Non-Championship.

To be received by the Secretary of the meeting on or **before FIRST POST Saturday, 2nd April 2016** together with the correct entry fee of **£25***, plus 1 SAE for Final Instructions if you do not supply an Email address.

All cheques to be made payable to **Yeadon Guiseley DMC Ltd.**

No telephone, Email or late entries will be accepted.

Separate cheques to accompany each entry – no multiple cheques will be accepted.

Return of Fees: An entry fee will only be returned if the event is cancelled or postponed for more than 24 hours.
Riders who cancel their entry after the closing date will NOT receive a refund.
