**ROUND 4 OF THE ACU S3 PARTS NATIONAL TRIALS CHAMPIONSHIP**  
**ORGANISED BY LLANGOLLEN & DISTRICT MOTORCYCLE CLUB**

**ON MONDAY 28TH MARCH 2016 – PERMIT NO: ACU**

**Announcement:** The Llangollen & District Motorcycle Club WILL ORGANISE A NATIONAL TRIAL HELD UNDER THE NATIONAL SPORTING CODE, THE TRIALS STANDING REGULATIONS OF THE ACU, THE ACU S3 PARTS NATIONAL TRIALS CHAMPIONSHIP REGULATIONS AND ANY FINAL INSTRUCTIONS THAT MAY BE ISSUED.

**ALL COMPETITION IS ON PRIVATE LAND. COMPETITORS WILL USE PUBLIC HIGHWAY TO REACH SECTIONS. NO COMPETITION WILL TAKE PLACE ON PUBLIC HIGHWAY.**

IT IS THE RIDERS' RESPONSIBILITY TO ENSURE THAT BOTH HIS MACHINE AND RIDER ARE FULLY LEGAL FOR THE PURPOSE. RTA INSURANCE IS AVAILABLE TO PURCHASE.

THE ENTRY FEE IS **£25.00** PER ADULT WHICH INCLUDES THIRD PARTY (OFF ROAD RISK ONLY) INSURANCE, TRIALS LEVY.

THE ENTRY IS LIMITED TO 120 PERSONS AND THE ENTRY WILL CLOSE ON FRIDAY 27<sup>TH</sup> MARCH 2015 OR WHEN FULL (WHICH EVER IS FIRST)  
START ORDER WILL BE BY OF RECEIPT OF VALID ENTRIES - EARLY ENTRY EQUALS LATE NUMBER

**NB Rider numbers will be allocated on a first come first served basis in the order that entries arrive, as we have always done i.e. the earlier you enter the later your start time will be. If you wish to ride with your friends or if you are travelling in a group then please send your entries together in one envelope. No exceptions. I have been asked by the ACU to inform competitors that entering the event and then failing to turn up (unless you have a very good reason) is frowned upon.**

**Eligibility:** RIDERS MUST HOLD A CURRENT ACU TRIALS REGISTRATION CARD or SACU LICENCE. OTHER RIDERS MUST PRODUCE A LICENCE AND START PERMISSION CONFIRMING INSURANCE FROM THEIR FMN.

CLASSES:-

- A- CHAMPIONSHIP (ELIGIBLE FOR CHAMPIONSHIP POINTS)**
- B- CHAMPIONSHIP ROUTE ON A MACHINE NOT EXCEEDING 125CC**
- C- CHAMPIONSHIP ROUTE BUT INELIGIBLE FOR POINTS**
- D- NON-CHAMPIONSHIP (INCLUDING SOME SECTIONS ON EASIER ROUTE)**

START TIME FOR THIS EVENT IS 9.30 A.M.

THE TRIAL WILL START AT: THE GLYN VALLEY HOTEL, GLYN CEIRIOG. LL20 7EU

THE COURSE WILL CONSIST OF 1 LAP OF APPROX 36 SECTIONS AND APPROX 35 MILES

MACHINE EXAMINING AS REQUIRED IN THE STANDING REGULATIONS. ALL RIDERS **MUST** WEAR HELMET AND BOOTS SUITABLY APPROVED AT ALL TIMES WHILST RIDING.
