Announcement: Yeadon Guiseley DMC Ltd will organize a National trial held under an ACU Special Permit. The event will be organized in accordance with the ACU National Sporting Code, the ACU Trials Standing Regulations with the following amendments, together with these Supplementary Regulations and any final instructions that may be issued.

Method of Marking: The method of Marking will be as TSR22.A Stop Permitted with the following amendments.

- a) There will be no penalty if the machine moves backwards without footing. Any backward movement whilst footing will be classed as a failure.

Eligibility: Riders must hold a current ACU or SACU License or Registration card. Riders from other Federations must produce a License and Start Permission from their FMN confirming Insurance to the FIM requirements.

Start: The start will be at Addingham Moorside, Light Bank Lane, Silsden BD20 0NL

First rider will start at 10.00am

All riders must attend the Riders briefing at 09.30am

Entries: Entry Limit **30**.

Invitations will be sent to the Top 10 positions in the final Classification of the British Solo Trials Championship 2015 as per the list issued by the ACU Trials & Enduro Committee dated May 2016. Priority of entry will be given to these riders up until the closing date of First Post on 22nd August. Any remaining available places will then be offered to other riders who have submitted an entry and in the date order their entry was received by the Secretary of the meeting. Any rider who falls into this category though, cannot be guaranteed a ride.

Entry fee and fully completed Entry Form to be received by the Secretary of the Meeting by First Post Monday, 22nd August 2016. Cheques to be made payable to Yeadon Guiseley DMC Ltd.

No telephone, Email or late entries will be accepted. Entry will not be refunded if a rider cancels after the closing date.

Assistants: Each rider will be allowed to register one Assistant at a cost of £10.

Course: The course will consist of 10 sections. Will be on private land. Practicing on land used for the trial before, during or after the event is forbidden and will result in disqualification.

Qualification: All riders will take part in the qualification, which will consist of 2 laps.

Semi Final: The highest placed 8 riders from the qualification will compete.
Starting order 8th, 7th, 6th, 5th, 4th, 3rd, 2nd, 1st. Riders start with zero marks lost.

Grand Final: The highest placed 4 riders from the Semi Final will take part in the Grand Final.
Starting order 4th, 3rd, 2nd, 1st. Marks lost in the Semi Final will be carried forward to the Grand Final.

The number of Sections for the Semi Final and Grand Final will be announced at the riders briefing.

Prize Money:

4 th	£100

Trophies will be presented on the day and riders must attend the presentation in riding gear.

Trophies to be held for 1 year.

Refreshments: Will be available throughout the day.
